MISCELLANEOUS INFORMATION

ALL FEES ARE CHARGED AT THE CURRENT RATES WHEN SERVICES ARE PROVIDED. FEES MAY CHANGE DURING YOUR ADOPTION PROCESS.

UPDATES ARE REQUIRED IF A FAMILY DOES NOT RECEIVE A PLACEMENT WITHIN THE STATE MANDATED TIME FRAMES (USUALLY 12 MONTHS). ADDENDUMS MAY BE REQUIRED FOR VARIOUS LIFE CHANGES (JOB CHANGE, MOVE, ETC.).

ADVOCACY EFFORTS BEYOND A TYPICAL HOME STUDY TOWARD STATE FOSTER ADOPTIONS AND/OR ICPC ASSISTANCE WILL BE BILLED THE HOURLY RATE OF \$140 IN ¼ HOUR INCREMENTS.

FAMILIES WITH ADDITIONAL ADULT HOUSEHOLD MEMBERS, PREVIOUS CRIMINAL HISTORY, MENTAL HEALTH CONCERNS, MEDICAL HISTORY AND OTHER ASPECTS THAT REQUIRE ADDITIONAL CONSULTATIONS FROM ABI'S CLINICAL TEAM OR CASE WORKERS WILL BE CHARGED FOR THE ADDITIONAL TIME REQUIRED TO ASSESS THEIR CASE AT THE HOURLY RATE OF \$140 IN ¼ HOUR INCREMENTS. FAMILIES WHO HAVE RESIDED IN MULTIPLE STATES AND/OR OTHER COUNTRIES WILL BE CHARGED ADDITIONALLY FOR THE STAFF TIME TO COORDINATE RECEIPT OF REQUIRED CHILD ABUSE CHECKS.

MILEAGE IS CHARGED AT .52 PER MILE AFTER THE FIRST 100 MILES. EXTENSIVE TRAVEL TIME WILL BE INVOICED TO THE FAMILY AND PAID THROUGH THE AGENCY FOR APPROPRIATE DISTRIBUTION.

HOME STUDY FEES ARE DUE AS FOLLOWS: 50% AT THE TIME OF APPLICATION AND 50% PRIOR TO HOME STUDY FINALIZATION. 50% IS REFUNDABLE AFTER THE FIRST HOME VISIT SHOULD A FAMILY ELECT TO WITHDRAW. AFTER THE SECOND HOME VISIT, NO HOME STUDY FEES ARE REFUNDABLE. HOME STUDIES MAY NOT BE RELEASED UNTIL ALL FEES ARE PAID.

DOMESTIC PLACEMENT FEES ARE SUBJECT TO CHANGE AT THE BEGINNING OF EACH YEAR. FAMILIES RECEIVING A DOMESTIC ADOPTION THROUGH ABI WILL BE EXPECTED TO PAY THE FEES CURRENT AT THE TIME OF PLACEMENT. IF A MATCH AGREEMENT HAS BEEN COMPLETED IN THE YEAR PRECEDING THE CHILD'S BIRTH/PLACEMENT, FEES WILL BE DUE AS CONTRACTED.

FINANCIAL AGREEMENT

ALL CLIENTS THAT SIGN AN AGREEMENT FOR ADOPTION WITH ABI WILL ADHERE TO THE FOLLOWING GUIDELINES REGARDING PAYMENTS TO ABI:

1. ALL ACCOUNTS THAT ARE 30 DAYS PAST DUE WILL BE SUBJECT TO 1 ½ % INTEREST
2. IF FOR ANY REASON YOUR ACCOUNT HAS TO GO TO A COLLECTION AGENCY AND/OR ATTORNEY FOR COLLECTIONS, YOU WILL BE RESPONSIBLE FOR ANY AND ALL FEES ACCRUED BY THE COLLECTION AGENCY AND/OR ATTORNEY
3. THERE WILL BE A \$50 RETURN CHECK FEE FOR ALL CHECKS RETURNED
4. REPORTS WILL NOT BE SENT IF ACCOUNTS ARE NOT CURRENT
5. ABI RESERVES THE RIGHT TO REVOKE A POSITIVE HOME STUDY IF FEES ARE NOT REMITTED IN A TIMELY WAY
6. SHIPPING CHARGES TO DELIVER HOME STUDIES, REPORTS, ETC. WILL BE BILLED TO THE CLIENT FAMILY
